REMOTE EDUCATION POLICY

Aims and Objectives

In order to ensure that children are still learning and making progress, even in the event of another full or partial lockdown, Warnham CE Primary has developed this Remote Education Policy. This policy outlines ways in which the curriculum will continue to be taught, the electronic resources needed and contingency plans for families that do not have access to devices and the internet. This plan will be applied in the following instances:

1. An individual is self-isolating because of a positive Covid-19 test
2. A whole bubble or cohort is home learning due to high staff absence

This plan complies with the expectations and principles outlined in the DfE document Guidance for Full Opening of Schools.

Access to Home Learning Materials

Software and online platforms

Within all plans, teachers will set appropriate work in-line with our current curriculum, on Google Classroom or through ParentMail, primarily supplemented by a range of resources provided by Oak Academy or White Rose Maths.

Children will remain in contact with their class teacher through Google Classrooms and individual year group email addresses (to share successes and communications).

Google Classroom has been selected to support remote learning. All of the teaching staff have received training in how to use Google Classroom. It allows us to set assignments, quizzes, and use a range of resources to enable children to access learning similar to the face to face teaching that they would receive in school. The use of Google Classroom will enable teachers to provide pre-recorded lessons and allow the children to take part in class discussions. It allows teachers to communicate well with their class, even though they are not physically together. Teachers will be able to set work, be able to see which pupils have completed their work and provide direct feedback and further support.

Lessons may be supplemented by reference to BBC Bitesize and Oak Academy lessons, if relevant to the current topics being taught across the school. These online lessons are free to all and offer a recorded taught session so that children can access physical teaching from a teacher and then access work relating to that lesson within the same website. There are also hundreds of lessons specifically aimed at children with SEND needs and requiring additional support.

White Rose lessons and resources will be used as they are matched to our current maths curriculum model. The children are very used to seeing these resources.

Additionally, children will be given activities from Mathletics, Times Tables Rockstars, Phonics Play, Spelling Shed, Letter Join and other appropriate websites to support their acquisition and retention of basic core skills.

The year group email address will remain in use as the main communication element. Teachers and parents will be able to message one another to share information and offer support.

In the event of any form of isolation and loss of learning, engagement in home learning is compulsory for all year groups, as is the expectation that Warnham CE Primary School makes that

provision available and accessible to all. However, if children themselves are too ill to attend, then they should not be expected to engage in home learning.

In preparation for home learning, parents and children need to receive logins and passwords for the following platforms (likewise teachers need to be familiar with them):

- Google Classroom (passwords managed by home, School Admin can reset)
- Mathletics
- Times Table Rockstars
- Spelling Shed
- SPAG.com (Y5 and Y6)

Remote Learning

The initial response to any isolation will be to provide children with home learning materials. In the event of a whole school/cohort isolation, resources will initially be uploaded onto Google Classroom. Children who do not have access to any devices or the internet will be loaned a device / provided with internet data in the first instance or have packs prepared for them by their class teacher if absolutely essential (as this is very labour intensive). This will enable the children to continue learning alongside the rest of their class. Devices/data/packs can be picked up from the school office.

Content for Phonics*

- In the event of a full closure teachers will record a video of the daily phonics lesson for children to watch at home.
- In the case of an individual child self-isolating the teacher may inform parents which phonemes are upcoming in the teaching sequence and direct them to BBC Bitesize, Letters and Sounds DFE lessons on YouTube and Phonics Play.

Content for English*

- In the event of a full closure, teachers may direct pupils and parents to a recorded video on Google Classroom or lessons from the Oak Academy.
- In the event of an individual child self-isolating the teacher may put appropriate links to Oak Academy on Google Classroom

Content for Maths*

- In the event of a full closure, teachers may direct pupils and parents to a recorded video on Google Classroom or lessons from White Rose.
- In the event of an individual child self-isolating the teacher may put appropriate links to Oak Academy on Google Classroom

Monitoring Engagement with Remote Education

It is important that children engage with the remote education provided so that they don't fall back with their learning, however we do acknowledge that each family's home circumstances are unique and there may be factors that affect engagement with home learning. These may include parents working from home or limited access to technology amongst other factors.

Communication is essential and we would ask that if there are circumstances that mean a child cannot engage at least partially with the remote education that their parent speaks to the teacher. We understand that families may have limited devices and access to fast broadband. With this in mind we will be pre-recording lessons in the event of a whole class or whole school closure so that they can be accessed at a time that works best for the family

A Typical Day of Home Learning

Early Years

Children in Early Years will have 2 hours maximum of suggested learning each day. The minimum expectation is that children should be trying to do daily Phonics and Maths. Ideally, they will also access a physical activity (gross or fine motor skills), an activity from another strand of the curriculum as well as sharing the class story. Children in Early Years will also be practising skills such as using a knife and fork, holding conversations, turn taking, sharing, listening to and following instructions, getting dressed independently, engaging in role play and following their own learning pathways.

Key Stage 1

Children in Key Stage 1 will be given 3 hours of work to complete per day. The minimum expectation is that children should be trying to do daily English, Maths and Phonics. Ideally, they will also do another area of learning or practise some key skills as well as daily physical exercise.

Key Stage 2

Children in Key Stage 2 will be given 4 hours of work to complete per day. The minimum expectation is that children should be trying to do daily Guided or Independent Reading, English and Maths as well as a topic area and practising some key skills as well as daily physical exercise.

Engagement

Teachers will be monitoring engagement in Google Classroom when appropriate and will report back to the Senior Leadership Team (SLT) about any concerns. They will then contact families to discuss any issues and barriers that the child/family may be experiencing.

Provision of Remote Learning in Different Scenarios

Using Google Classroom, the Class teacher will upload worksheets by 5:00pm the day before to allow parents to see the learning materials prior to supporting their child/ren.</p> <p>PPA may be covered as normal by the relevant staff to the year group.</p> <p>The Class teacher will share links to appropriate lessons from Oak National lessons through Google Classroom. Expectations of Quality of Work

Teachers have the same expectations of the quality of work produced at home as they do at school, although it is recognised that this is difficult to implement. In situations where work is not at the expected level of presentation, teachers will contact children and parents directly to discuss any issues and concerns.

Teacher Workload

We care very much about our teachers and value them as highly trained professionals. We understand that moving to online learning is not what they have been trained to do and, like it is a learning curve for families, it is also a learning curve for teachers. If you are concerned about aspects of the home learning provided for your child, please let their class teacher know directly. Being mindful of their workload, as per our policy, they will respond to you during school hours within 2 working days where appropriate.
